The Cultural Secretariat of IILA - Organizzazione Internazionale Italo-Latino Americana is issuing a call for papers to contribute to the issue 3 of *Quaderni Culturali IILA* review 2021.

One of the fields in which the rise of the digital humanities has had a significant impact is Latin American studies. Various gatherings¹, publications² and organisations³ have examined the advantages and challenges posed by the digital humanities for scholarly activity addressing, or originating from, Latin America. It goes without saying that the relationship between Latin American studies and the digital humanities can prove mutually beneficial, providing the former with an opportunity to expand its lines of inquiry and innovate its theories, while the latter is facilitated in carrying out a critical analysis of the colonisation of knowledge⁴. The new issue of the review of the IILA, *Quaderni Culturali* (Cultural Notes), will explore the practices and methods of the digital humanities in the context of Latin American

CILE	The review <i>Quaderni Culturali</i> invites scholars and institutions, as well as users of digital humanities platforms or projects, to present articles on projects of the digital humanities relevant to the artistic and cultural heritage of Latin America. In line with the review's editorial outlook, areas of particular interest are the circulation of art within Latin America, and between Latin America and the rest of the world, though all articles on projects of relevance to Latin American culture are welcome, and regardless of the geographic area from which they originate. Some of the questions raised in this new issue of the review will be: what stage of development have the digital humanities reached with respect to the arts in - and from - Latin America? What specific challenges and problems face the digital humanities in addressing the cultural heritage of Latin America? What new reflections arise when the study of "Latin American art" encounters the digital humanities? What type of dialogue can be established between the tools and initiatives of the digital humanities and the modern project of a "Latin American culture"? What benefits or challenges does Latin America pose to the digital humanities?

ITALIA	Potential subjects include: projects of digitalisation and crowd-sourced databanks; tools developed for distant reading and digital image processing; quantitative cultural analysis; guidelines for digital publication and dissemination; visualisation and mapping (GIS); curating of digital collections; educational projects; 3D digitalisation; virtual experiences; the history of the digital humanities on the continent, to mention only a few possibilities.

NICARAGUA	An article proposal of no more than 300 words must be presented, and each proposal must be accompanied by identifying information on the candidate (name, institution, address, e-mail address, telephone number), plus a biographical profile of no more than 150 words. The proposals are to be presented by 6 April 2021. The languages accepted are: Italian, Spanish, Portuguese, French and English.

The final text, which must also be reviewed, is to be presented by the end of July 2021. The articles must be previously unpublished, and they may not be currently under submission to other
